CHICAGO BEARS 2024 SCHEDULE PREDICTION CHALLENGE BROUGHT TO YOU BY UNITED OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. HOW TO ENTER: The Chicago Bears 2024 Schedule Prediction Challenge (the "Promotion") starts April 16, 2024 at 10:00AM Central Daylight Time ("CDT") and ends on April 28, 2023 at 11:59PM CDT. Sponsor's computer shall be the official timekeeper for all matters related to this Promotion. To enter the Promotion: (a) visit ChicagoBears.com/prediction or open the Chicago Bears Official App and tap on "More" and then "Schedule Prediction Challenge"; (b) click on "Enter Now"; (c) guess the order of the Chicago Bears 2024 regular season opponents including the location for each game against divisional opponents and the week that the Chicago Bears will have its bye week ("Schedule") and click on "Submit Your Predictions"; (d) complete the entry form by providing your name, email address, date of birth and zip code; and (e) check the box confirming that you agree to the Promotion's official rules and click on "Submit" (individually, an "Entry", or collectively, "Entries"). You do not need to sign up for Bears Direct, exclusive Chicago Bears events, offers and promotions, Chicago Bears tickets or exclusive offers and promotions from United in order to submit an Entry. Limit five (5) Entries per person. The NFL schedule will not be finalized until early to mid-May even though the promotion ends on April 28, 2024.
- 2. ELIGIBILITY: The Promotion is open to all legal residents of the United States, excluding residents of New York, Florida, and Rhode Island, ages 18 years and over as of April 16, 2024. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. WINNER SELECTION**: Based on the official 2024 NFL regular-season schedule (released by the National Football League ("NFL")), the entrant (if any) as determined by Sponsor in its sole discretion, who predicted the accurate Schedule including the exact order of all opponents (including location for division opponents) and bye week, will be selected as the "Grand Prize Winner". In the event that no entrant submits an entry that correctly predicts the Schedule, the Grand Prize will not be awarded. In the event that more than one (1) entrant submits an entry that correctly predicts the Schedule, Sponsor will award the Grand Prize to the entrant that submitted the correct entry first (according to Sponsor's records) and the other entrant(s) will not receive the Grand Prize or any other prize.

The Grand Prize, Second Prize, and Runner Up Prizes are referred to collectively as the "Prizes".
